# City of Baltimore Quarterly Treasury Report AT-A-GLANCE April 2024

The Mayor's Office of Recovery Programs (Recovery Office) is required to submit quarterly reports to the U.S. Department of Treasury on the City's use of American Rescue Plan Act (ARPA) funds. The Recovery Office submitted its seventh report on April 30, 2024. This At-a-Glance document summarizes funds obligated and expended from January 1, 2024, through March 31, 2024 - the end of the reporting period. Since the last quarterly Treasury Report, the Recovery Office has seen an approximate increase of 26.7% in ARPA spending overall on all projects.

For purposes of reporting to the U.S. Treasury, obligated means all payroll expenses to date and the amount of funding committed to external parties by contract or grant; Expended means the total amount of funds spent as of the end of the reporting period. Mayor Brandon M. Scott, through the Baltimore City Department of Housing and Community Development and Mayor's Office of Homeless Services, announced the names of the awardees of the \$30 million Housing Accelerator Fund. These awardees will develop affordable and permanent supportive housing in Baltimore City. Additionally, during this reporting period, Mayor Scott announced the \$3.6 million Diversity in Arts Grant Awardees in collaboration with the United Way of Central Maryland.

The **Baltimore City Department of General Services received \$5.1 million** to purchase 20 load packers on behalf of the **Department of Public Works**. DPW used these load packers to support the return to the city-wide weekly recycling program.
