City of Baltimore Quarterly Treasury Report AT-A-GLANCE January 2024

The Mayor's Office of Recovery Programs (Recovery Office) is required to submit quarterly reports to the U.S. Department of Treasury on the City's use of American Rescue Plan Act (ARPA) funds. The Recovery Office submitted its seventh report on January 31, 2024. This At-a-Glance document summarizes funds obligated and expended from **October 1, 2023, through December 31, 2023** - the end of the reporting period. Since the last quarterly Treasury Report, the Recovery Office has seen an **approximate increase of 36% in ARPA spending overall on all projects.**

Mayor Brandon M. Scott and the Office of Broadband and Digital Equity (BDE), a division of the Baltimore City Office of Information and Technology (BCIT), announced the implementation of **Baltimore's free public Wi-Fi network: FreeBmoreWiFi**. The initiative, announced in the fourth quarter of 2023, is funded by ARPA through the Mayor's Office of Recovery Programs. Currently, residents can access public Wi-Fi for free at Solo Gibbs Recreation Center, Middle Branch Fitness and Wellness Center, Baltimore Rowing, Water Resource Center, and the soon-to-be online, Shake n' Bake Family Fun Center.

Mayor Scott also held groundbreakings for ARPA-funded Baltimore City Recreation and Parks projects and the Park Heights Senior Apartments. BCRP locations included Radecke and Indiana Avenue Playgrounds.
